LECTURES: Professor Denbeaux is invited to speak frequently to Law Schools, Colleges, Academic Conferences as well as churches, high schools, religious conferences and other public interest groups. The topics are generally in his three areas of professional and academic interest: Race, Guantanamo, Torture and National Security; and Forensic Evidence.

Professor Denbeaux’s commitment to the issues of race in America grew out of his experiences in the South in the 1960’s from the March on Washington to the March from Selma, Alabama to Montgomery, Alabama. He speaks frequently about his experiences including his years in the South Bronx in the 1970’s. Following graduation from law school, he was a founding member of the South Bronx Legal Services. His civil rights work and scholarship continue.

Professor Denbeaux’s involvement Guantanamo, Torture and National Security began when the Supreme Court recognized that detainees had right to legal counsel. In 2005 he began to represent two detainees, both eventually released. Subsequently he represents two men who were held in CIA dark sites. He writes and speak frequently on these issues.

Professor Denbeaux’s third area of interest focuses on the defects of the trial system in general and specifically defects in forensic evidence. In addition to speaking on these areas he is also asked to speak on evidentiary and trial issues.
