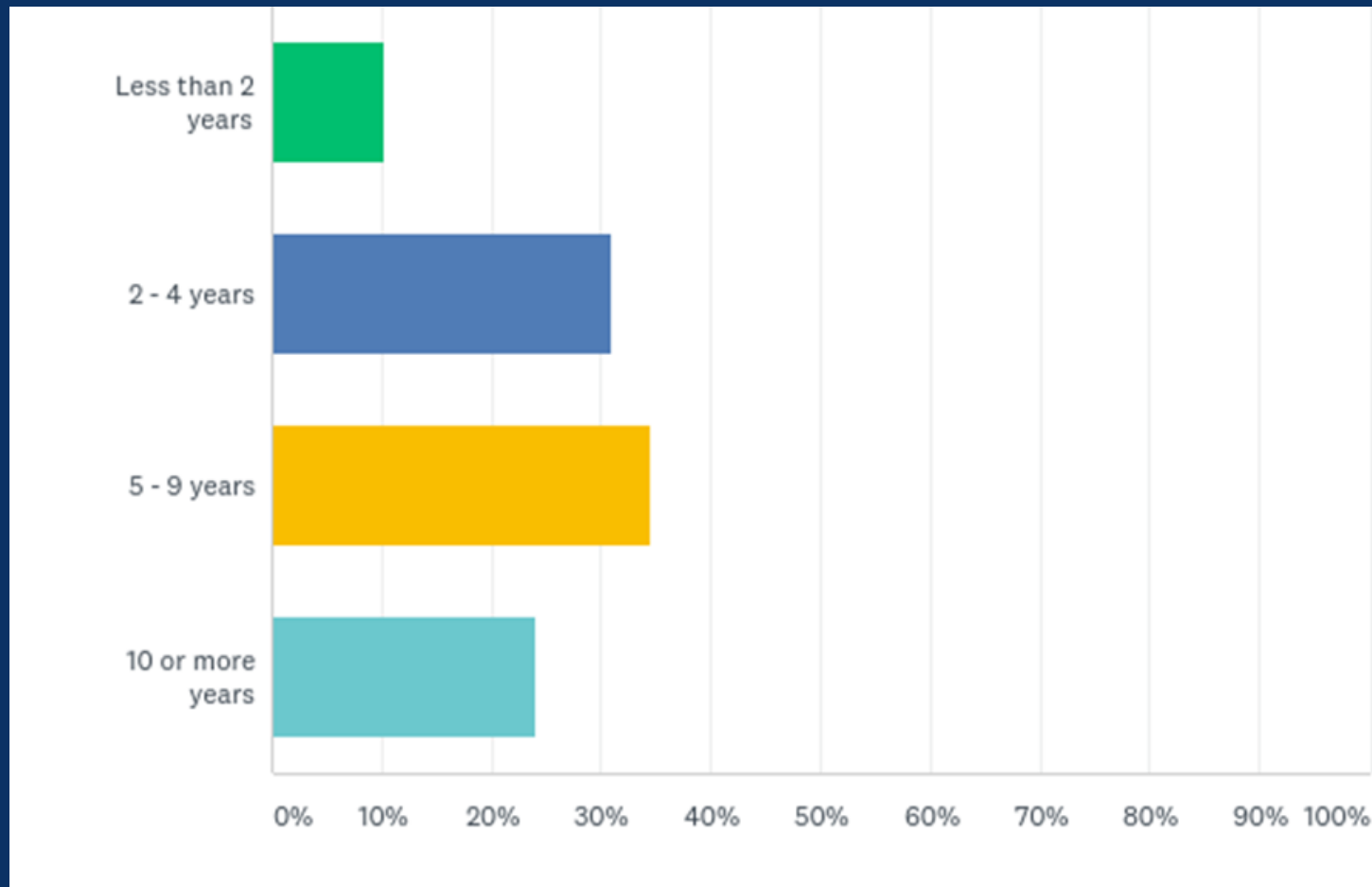

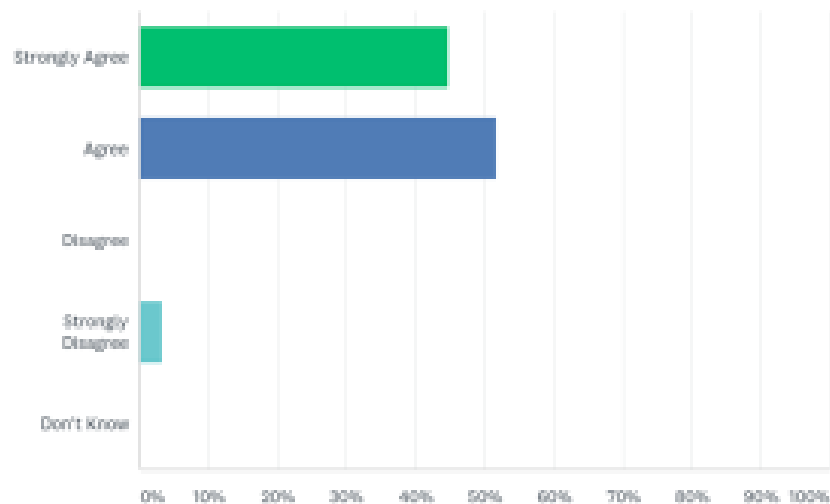
My Company's Compliance Program Can Be Described As
