Chief Judge Chagares's dedication to public service is perhaps most powerfully demonstrated by his work as a Hearing Officer for the 9/11 Victim Compensation Fund. In the aftermath of a difficult time in our nation's history, he helped families navigate profound loss and ensured that justice and compassion guided the nation's response. His role required not only legal expertise, but also empathy, fairness, and a deep sense of civic responsibility.

What makes Judge Chagares especially meaningful to us today is not just his distinguished résumé, but his ongoing commitment to Seton Hall Law. As an adjunct professor for over three decades, he continues to teach and inspire in our own classrooms. He remains part of our community, guiding and supporting students as they find their own paths in the law. He understands that true greatness as a lawyer and leader is measured not solely by personal achievements, but by a steadfast dedication to uplifting others and guiding them toward success alongside him.
