Speaker Biographies

David W. Opderbeck, *Professor of Law and Director, Gibbons Institute of Law, Science & Technology, Seton Hall University School of Law*

Professor Opderbeck's work focuses on the regulation of access to scientific and technological information. His published work has employed the tools of game theory, classical microeconomics, and statistical analysis to address issues such as settlements in Hatch-Waxman litigation, cybersecurity policy, intellectual property restrictions on essential medicines in developing countries, open source biotechnology, patent damages reform, and the interaction of law and social norms concerning music file sharing.

Professor Opderbeck's interest in cybersecurity law and policy included a multi-year grant-funded project sponsored by the Bergen County, New Jersey Prosecutor's Office, which included new courses, continuing legal education programs, and the creation of a governmental working group on cybersecurity and cybercrime. The governmental working group recently worked on a new online child pornography bill that was signed into law by Governor Christie. Professor Opderbeck frequently lectures to law enforcement agencies and other groups on cybercrime, cyberterrorism, and civil liberties.

In addition to his traditional legal scholarship, Professor Opderbeck is interested in the philosophical and moral foundations of information policy and other aspects of the law. He has written on ethical, philosophical and theological issues in law and jurisprudence, and currently is completing a doctorate in philosophical theology regarding the intersection of neuroscience and the law.

Ken Corsello is responsible for IP Law issues for IBM's Storage and microelectronics groups. While at IBM, he has worked on litigation, patent procurement, IP policy, and IP transactional matters. Before joining IBM, Ken was a law clerk to Chief Judge Glenn Archer at the Federal Circuit, an Associate Solicitor in the USPTO, and he worked at law firms in Washington, DC. He is chair of IPO's Trade Secret committee.

Ken did his undergraduate work in Computer Science at SUNY Stony Brook, received his JD from the Catholic

University, and obtained an LL.M. from George Washington University. He has taught classes in patent law at Catholic University.

In addition to his intellectual property practice, Mr. Troublefield has represented clients in bankruptcy, family law, construction, false advertising, product liability, and environmental matters in State and/or Federal Courts.

Mr. Troublefield serves on the Statewide Panel of the New Jersey Supreme Court's Committee on Character and has served as a member of the New Jersey Supreme Court's Ethics Committee. In addition, he is an active member of the American Bar Association, the National Bar Association, and the New Jersey State Bar Association. He has also served on several ABA Task Forces and Committees and organized and appeared as a speaker for programs sponsored by the ABA and NJSBA related to topics such as diversity in the profession, professionalism and intellectual property law.

Sharon K. Sandeen, *Director, Intellectual Property Institute, Robins Kaplan Distinguished Professorship in IP Law, Mitchell Hamline Law School*

Professor Sharon K. Sandeen is director of the IP Institute at Mitchell Hamline and an internationally recognized expert on trade secret law, having written three books (with E. Rowe) and more than 25 articles and book chapters on trade secret law and other intellectual property topics, including the first casebook on trade secret law in the United States (*Cases and Materials in Trade Secret Law*), a book on international trade secret protection (*Trade Secrecy and International Transactions*), and detailed examinations of the drafting histories of the Uniform Trade Secrets Act and Article 39 of the TRIPS Agreement. She is also the editor of the *IP Deskbook for Business Lawyers*, now in its third edition.

A native of northern California, Professor Sandeen earned two degrees from the University of California Berkeley; a Bachelor of Arts degree in Political Science and a Masters of Law degree from U.C. Berkeley School of Law (Boalt Hall). She earned her Juris Doctorate from the University of the Pacific, McGeorge School of Law, graduating at the top of her class. Her teaching career began in 1996 when she was appointed an adjunct professor at McGeorge. She began full-time teaching in 2002 at Hamline University School of Law in St. Paul, Minnesota, now Mitchell Hamline School of Law.

Since 1996, Professor Sandeen has taught an IP survey course at least once a year as well as a variety of other IP courses, including Trademark Law, Copyright Law, Computer & Internet Law, Trade Secret Law, and International Intellectual Property Law. Prior to becoming a professor, she practiced law for more than 15 years in Sacramento,

California, first as a general business and IP litigator at the largest law firm in Sacramento and later as an intellectual property specialist at a boutique firm.

Professor Sandeen was elected as a Fellow of the ABA Foundation in 2012. She was elected to membership in the American Law Institute in 2016.

Gaia Bernstein, *Michael J. Zimmer Professor of Law; Director, Institute for Privacy Protection and Co-Director, Gibbons Institute of Law, Science & Technology, Seton Hall University School of Law*

Gaia Bernstein is the Michael J. Zimmer Professor of Law, Director of the Institute for Privacy Protection and Co-Director of the Gibbons Institute of Law Science and Technology. Professor Bernstein specializes in law and technology, information privacy, health privacy, intellectual property, law and genetics and reproductive technologies. Her scholarship examines the role of users in the adoption of new technologies across diverse doctrinal areas. She is currently working on a book tentatively titled "The Over-Users," which focuses on over-use of information technologies and technological addiction. Professor Bernstein's scholarship has been published in leading law reviews including the Vanderbilt Law Review, the Boston College Law Review, the Boston University Law Review, the Washington Law Review and the U.C. Davis Law Review. Her work has been selected to the Stanford-Yale Junior Faculty Forum and received extensive media coverage. Professor Bernstein was the Chair of the Section on Privacy and Defamation and a member of the Executive Board of the Section on Intellectual Property of the American Association of Law Schools.

Professor Bernstein has joined the Seton Hall faculty in 2004. Prior to joining the Seton Hall faculty, Professor Bernstein was a fellow at the Engelberg Center of Innovation Law & Policy and at the Information Law Institute at the New York University School of Law. Her degrees include: a J.S.D. from the New York University School of Law, an LL.M. from Harvard Law School, a J.D. (Intellectual Property concentration with Honors) from the Boston University School of Law, and a B.A. in Psychology and Political Science (magna cum laude) from Tel Aviv University. Professor Bernstein practiced law at Skadden, Arps, Slate, Meagher & Flom LLP in New York and at S. Horowitz & Co. in Israel.
