#### Police Diversion

- Police Diversion Programs enable police to offer eligible persons, apprehended for minor drug offenses and low-level crimes, an opportunity to attend and complete treatment rather than going to jail.
- Police use their discretion regarding suspected opiate addicted individuals and can intervene at the time of arrest or before a crime is committed.
- Police can use their training, expertise and experience to screen individuals and identify those who are appropriate for treatment rather than incarceration.

### The Process

#### STEP 1 - DETAINMENT

What do candidates look like?

As the Law Enforcement Community knows, individuals suffering from a substance abuse disorder (S.U.D) can be difficult to work with.

Individuals may be withdrawing from drugs or alcohol and may initially be anxious or uncooperative.

Individuals abusing substances may also have simple possession charges, low-level offenses, or other outstanding legal issues.

The intervention of Law Enforcement at this crucial juncture can make the difference in getting these individuals into successful treatment.



### The Process

#### STEP 2 - CONTACT RECOVERY SUPPORT SERVICES

A call is placed to Lifeline Recovery Support Services (1-888-520-0040)

A Peer Recovery Specialist is deployed and responds within the hour - to wherever the incident has occurred.

Law enforcement holds the individual and waits for the Certified Peer Recovery Specialist to arrive.





### The Process

#### STEP 3 - RECOVERY SPECIALIST ON-SITE

The Recovery Specialist meets the candidate in the designated area of the Police Station.

A Peer Recovery Specialist provides recovery support services to the affected person suffering from a substance abuse disorder.

The Peer Recovery Specialist works with the client and Recovery Services to develop and execute a plan for treatment.

The Peer Recovery Specialist Program runs at a 60 to 70% success rate when executed with the proper partnerships.








