Richard G. Frank, PhD is the Margaret T. Morris Professor of Health Economics in the Department of Health Care Policy at Harvard Medical School. From 2009 to 2011, he served as the deputy assistant secretary for planning and evaluation at DHHS directing the office of Disability, Aging and Long-Term Care Policy. From 2013 to 2014 he served as a Special Advisor to the Office of the Secretary at the Department of Health and Human Services and from 2014 to 2016 he served as Assistant Secretary for Planning and Evaluation in the Department of Health and Human Services. His research is focused on the

economics of mental health and substance abuse care, long term care financing policy, health care competition, implementation of health reform and disability policy. Dr. Frank served as an editor for the Journal of Health Economics from 2005 to 2014. Dr. Frank was awarded the Georgescu-Roegen Prize from the Southern Economic Association, the Carl A. Taube Award from the American Public Health Association, and the Emily Mumford Medal from Columbia University's Department of Psychiatry. In 2011, he received the Distinguished Service Award from the Mental Health Association of Maryland. Dr. Frank also received the John Eisenberg Mentorship Award from the National Research Service Awards. He was elected to the Institute of Medicine (National Academy of Medicine) in 1997. He is co-author with Sherry Glied of the book *Better but Not Well* (Johns Hopkins Press).

### Dorothea Dix Professor of Health Law & Policy, and Faculty Director, Center for Health & Pharmaceutical Law & Policy, Seton Hall University School of Law



John Jacobi is the Dorothea Dix Professor of Health Law & Policy at Seton Hall Law School. He teaches, researches, publishes, and works in the areas of health care access, finance and delivery reform, as well as disability rights and mental health discrimination. He is the Faculty Director of the Seton Hall Law School Center for Health & Pharmaceutical Law & Policy. He serves as Board Chair of the Greater Newark Healthcare Coalition, a community-provider collaborative dedicated to integrating care for Medicaid recipients in Newark, New Jersey, and as Vice-Chair of the North Jersey Community Research Initiative, an HIV

service and research organization. He participates in legislative and regulatory advocacy on behalf of low and moderate income residents. He has served as Principal Investigator for research projects in health reform, health access, and behavioral health areas. He has served as Senior Associate Counsel to the Governor of New Jersey, as Assistant to the Commissioner of the New Jersey Public Advocate, and as Gibbons Fellow in Public Interest and Constitutional Law. He is a *summa cum laude* graduate of the State University College of New York at Buffalo (Mathematics and Philosophy) and a *magna cum laude* graduate of Harvard Law School.

Brad Lerner is Associate General Counsel & Director of Parity Compliance for Beacon Health Options. Among his duties at Beacon Health Options, Brad creates strategies to implement the Mental Health Parity and Addiction Equity Act of 2008 (MHPAEA) and the Affordable Care Act. Brad advises and reports regularly to Senior Executives on health care reform developments. Brad is

In her role as OHA's Assistant Healthcare Advocate, she oversees the daily operations of the agency and provides subject matter expertise to staff as needed. "Sam" Muszynski currently serves as Senior Policy Advisor and Director of Parity Implementation and Enforcement at the American Psychiatric Association, a professional membership association headquartered in Arlington, Virginia representing over 36,000 physicians. He is responsible for the association's external and internal analysis activities regarding mental health and substance use disorder parity, health insurance, reimbursement matters, and formulary policy, including relations with the insurance and

managed care industry, corporate purchasers of health care, and Medicare/Medicaid reimbursement. Earlier in his career he served as the association's Director of the Office of Economic Affairs.

From 1985 to 1998, Sam was Manager of the Washington, D.C. office of Goldman, Marshall & Muszynski, a health care law firm; and Managing Director of the National Association of Addiction Treatment Providers, a trade association representing over 450 specialty health care providers. Tara Adams Ragone's research and writing for the Center focus on implementation of health care reform, integration of behavioral and physical health care, accountable care organizations, health care access, prescription drug abuse, and issues related to the representation of health care professionals. Presently, she is the project manager of The Sentinel Project, a project funded by the Robert Wood Johnson Foundation to assess New Jersey health plans' compliance with the Affordable Care Act.

Tara came to Seton Hall Law from the State of New Jersey, Office of the Attorney General, Division of Law, where she served as Deputy Attorney General in the Professional Boards Prosecution Section. She primarily prosecuted licensing actions before the State Board of Medical Examiners and the Office of Administrative Law and represented the State in federal civil rights

actions brought by licensees. She also twice appeared before the Supreme Court of New Jersey in a case of first impression involving a commercial speech challenge to the Court's Rule of Professional Conduct governing attorney firm names.

# MICHAEL D. REISMAN Assistant Attorney General, Health Care Bureau, New York State Office of the Attorney General



Michael D. Reisman has been an Assistant Attorney General in the Health Care Bureau of the Office of the New York State Attorney General since 2012, where he investigates and brings enforcement actions against insurers, providers, drug companies and other individuals and entities that engage in fraudulent, misleading, deceptive, or illegal practices in the health care market. Prior to joining the Attorney General's Office, he was a commercial litigator with several national law firms, handling health care, commercial, intellectual property, antitrust, and civil rights litigation in

courts around the country. In his pro bono practice, he played a central role in several cases that advanced the rights of consumers in the New York City and New Jersey mental health systems. Prior to receiving his law degree from the Benjamin N. Cardozo School of Law, Mr. Reisman was a therapist in inpatient and outpatient mental health facilities in California, New York City, and the Czech Republic, where he was a Fulbright Scholar and lived for four years. He has an M.A. in Psychology from the California Institute of Integral Studies and a B.A. from Williams College.

## ELIZABETH SPRING Attorney IV, California Department of Managed Health Care (DMHC)



Elizabeth Spring is DMHC's lead attorney for implementing federal and state law governing mental health and substance use disorder coverage. She directed the Department's legal, actuarial, and clinical review of plan filings submitted in 2014-2015 to demonstrate compliance with the Mental Health Parity and Addiction Equity Act and continues as a key member of the MHPAEA review team as it conducts onsite surveys of plan compliance. Previously, she directed the Department's evaluation of plan compliance with the Affordable Care Act's requirements for essential health benefits and with California's SB 946, the mandate to provide behavioral health treatment for

autism. Her first work at DMHC focused on drafting regulations, analyzing health care bills, and in reviewing compliance by several large HMO plans with the Knox-Keene Act and Medicaid regulations. Prior to working for the DMHC, Ms. Spring directed regional marketing, contracting, and publicity activities for national rehabilitation companies specializing in prosthetics and orthotics.

# ELLEN WEBER Professor, University of Maryland Carey School of Law, and Vice President for Health Initiatives, Legal Action Center



Ellen Weber created the Drug Policy Clinic to address practices that inhibit the expansion of drug treatment in communities and the criminal justice system and discriminate against individuals with histories of drug dependence. Ellen's interest in a multi-strategy legal practice, including legislative advocacy, individual client representation, and community organizing and education, is reflected in the clinic's work. She researches and writes in the areas of disability rights, women's treatment and the child welfare system, the development and analysis of state and national drug policy, the

integration of addiction treatment in mainstream medical practice, and the delivery of addiction treatment services under health care reform.

Ellen joined the law school faculty in 2002 after serving as the Senior Vice President for the Legal Action Center, a public interest law firm that specializes in drug, AIDS, and criminal justice issues. At the Center, she litigated disability rights and privacy cases, participated in federal legislative advocacy on civil rights, health care reform, and appropriations issues, and conducted education and policy work on health privacy and offender re-entry. She has recently returned to the Center to help lead its health care initiatives.

Ellen began her legal career as a trial attorney with the Department of Justice, Civil Rights Division, where she litigated Voting Rights Act cases that challenged discriminatory state and congressional reapportionment plans and local electoral systems. She received her law degree from New York University School of Law, where she served as an editor on the Review of Law and Social Change.
